

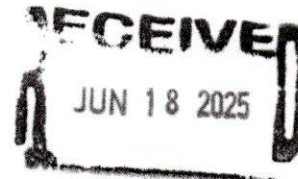


**STIPULATED ORDER GRANTING CLASS COUNSEL'S PETITION FOR
AWARD OF FEES AND COSTS**

On stipulation of the parties, Class Counsel's Petition for an Award of Fees and Costs is GRANTED. Further stated:

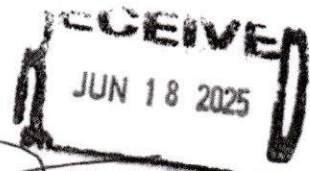
1. Class Counsel, collectively, are awarded an attorney fee of 1/3 (33.33%) of the total value created by the Settlement.
2. The attorney fee is \$280,247.00.
3. Class Counsel, collectively, are additionally awarded costs in the amount of \$8,875.86.
4. Defendants shall pay these amounts to Class Counsel within the time specified by the Settlement.
5. The Class Representatives, Bryan Zettel and Gail Zettel, collectively, are granted a Service Award of \$5,000.00.
6. Defendants shall pay this amount to the Class Representatives within the time specified by the Settlement.

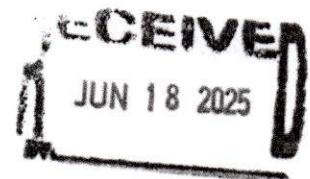
